Group Booking / Cancellation Policies & Agreement

Booking Agreement for ALL US Schools – Sponsors, Teachers, Adult Group Leaders, Parents & Individual Travelers

Student / Parent Inclusion, Payment & Policy – Tour Participant Agreement (TPA) –

Your school's price quoted is based on Per Person (PP) maximum (typically quad) hotel occupancy & does not include personal expenses. SAT **highly recommends** our travel / group / medical / cancellation insurance on any of your group's choice of packages. All groups are based on a preset number of people per coach with group leaders. Most groups are based on 48 to 52 full paying student / passengers at quad occupancy and 3 to 4 adult sponsors per motor coach (unless changed in written negotiations or shown on your School's Student/Teacher Trip Information Flyer). A per person surcharge may be offered to your group if its group size falls under your group minimum of passengers agreed to on coach or all units are not filled to pre-agreed capacity to avoid cancellation. Comfort Inns, La Quinta, Baymont Inn, Quality Inn, Double Trees, Econo Lodges, Hampton, Holiday Inn, Fairfield Inn, Ramada Inn & similar hotels / suites, as well as all events / venues may be interchanged, if booking or physical problems occur that would disrupt the tour. All Group Payments Are Non- Refundable, events happen rain or shine, name changes allowed for substitutions up until 5 days before trip departure on non-air or non-cruise programs only. + INDIVIDUAL CANCELLATIONS BY STUDENTS are allowed but limited to 20% of your group and are subject to the terms on your flyer and this TPA... Individual cancellation fee with written notice at 121 days out or more from departure is \$115 per person; within 120 days \$155 per person; within 90 days of departure \$205 per person and within 45 days of trip departure...No Refunds. If applicable vendor cancellation fees may apply also. Prices for all transportation methods used within any package bid more than 3 months (90 days) ahead of trip departure time maybe subject to Fuel Surcharges per D.O.T./E.I.A. Diesel Equity Acts ---- Group payments for your students' packages are made by your group leader/teacher/sponsor from 1 checking or group administered account. No checks directly from students / parents are accepted. \$75 insufficient funds fee for returned checks for any reason, plus applicable late penalties. Payments within 22 days of trip departure must be by money order or cashier's check only. Groups 15 days late on agreed payments will have a \$10 per person late fee automatically added to invoice. Groups 31 days late on payments, or groups not paid in full, to \$0 balance, by 25 days prior to departure date, automatically cancelled or billed re-booking fee of \$25PP, or subject to a reduction in trip time / venues with no refunds. Transportation delays for any reason will not be cause for refund but our goal is to remain flexible and work with your group's designated leader, the transportation supplier and all venues to make the traveling group as happy as possible due to any unforeseen travel delays (Typically Weather). **Paying deposit signifies that you & all parties concerned have read & understand these rules, regulations & payment policies thoroughly.**

ATTN: Teachers/Group Leaders, please make sure your students & the students' parents understand our booking/cancellation policy.... plus they understand that many student groups pick trip medical / accident / delay & individual cancellation insurance as a precaution... Plus ...be aware student groups have the ability for "Cancel for Any Reason" Insurance (except for NY State). Please read all insurance details thoroughly. --- Regarding Your School's Payments...Please understand...all payments will be made as GROUP PAYMENTS by the participating groups/schools with checks as invoiced. These payments are not refundable. Due to the amount of labor & resources expended on planning, marketing, implementation of the trips with vendors / school districts, and other group items we invest massive amounts of hours by our staff in order to get your trip to fruition. We could never withstand an entire group cancellation. Therefore, there are NO REFUNDS of these group payments. To recover a portion of or an entire group cancellation fee, you can purchase TRIP INSURANCE that could cover that expense at a very reasonable cost. If you choose that direction, we have plans that we can help you to make that cost even less.
